If you last contributed to TSERS and received a refund of your contributions in TSERS or former Law Enforcement Officers' Retirement System (LEORS), you may purchase retirement credit for this service in TSERS if you have a combined total of five years of membership service in the retirement systems listed in Section B. If you last contributed to LGERS and received a refund of your contributions in LGERS or former LEORS, you may purchase retirement credit for this service in LGERS if you have a combined total of five years of membership service in the retirement systems listed in Section B.
2. If you received a refund of your contributions in TSERS, LGERS, or CJRS, you may purchase retirement credit for this service in the System from which it was withdrawn if you have a combined total of five years of membership service in the retirement systems listed in Section B.
3. You have five years of contributing membership service.

If a member is no longer living, the purchase may be made by their surviving spouse provided the member had made application to purchase in writing, within 180 days from the last day of actual service, and further provided that the date of death occurred prior to or within 60 days after notification of the cost to make the purchase.

If you do not meet these requirements, do not submit this form.
